Sealed quotations are hereby invited from the interesting parties/ Agencies having experience to deal with the management of parking fees & parking matter in connection with 3 (three) years of lease for the management of parking fees of trucks/lorries at Dhupguri Municipality Truck Terminus, Ward No. 15 near Dhupguri Railway Station More to quote rate per month ~~more than the base price fixed for the purpose mentioned in terms & conditions below in the working days at Dhupguri Municipality Ward No. 10.~~

The last date of receiving sealed quotations at Dhupguri Municipality Ward No. 10 is 09/12/2024 upto 1:30 pm. and the sealed quotations will be opened at 3:00 pm. on the same day in presence of participating Agencies who would be present at the time of opening.

The participating Agencies / persons shall have to deposit earnest money of Rs. 10,000/- only either by draft or in cash in cash section of this Municipality on the working days before dropping /submitting the sealed quotations. However, the earnest money will be refunded to the unsuccessful quotationers.

The lease in question will be guided on the following terms & conditions.

Terms & Conditions:-

1. The lease period will be 3 (three) years from 15.12.2024.
2. There shall be 10% increase of rate after completion of every one year within the lease period of 3 year.
3. (a) The parking fee rate of local Truck/Lorries up to 24 hours – Rs. 70/-
(b) The parking fee rate of out sider Truck/big Lorries up to 24 hours – Rs. 200/-

The successful Agency shall n't claim more than the rate so fixed as above from the vehicle drivers / staff.

4. The successful highest quotationer to be selected shall have to deposit 1st (First) year amount in terms of his quoted rate per month within 7 days from the last date of dropping the quotation in Cash Section of this Municipality in ward N0. 10. Thereafter, he shall have to execute an agreement with the Municipality.
5. The successful Agency can use 2 (two) rest rooms, shade for rest for the vehicle staff, bathroom, toilets etc. in the said Truck Terminus complex but he can't be allowed to use Go-downs & other rooms to be constructed.
6. The Agency shall arrange security measure & sufficient light in the used area within the Truck Terminus in ward No. 15, Dhupguri. The Agency shall have to bear the electric bill expenses for the area to be used by him within the campus.
